

**Johnathan Juricek's Estate
TGRA Scholarship Program
Outline and Application**

Program Allocation of funds Available: Total \$10,000

- 1 TGRA will award four (4) education scholarships in the amount of \$2,000 each to a student who meets the requirement as outlined below. For a total of \$8,000. Candidates must be a TGRA member or related to a TGRA member in good standing or an external candidate as defined in 2c. under Eligibility / Requirements.
 - a. Application submission date / period is established as
April 1, 2018 to May 31, 2018 for the Fall 2018 semester.
- 2 TGRA will award scholarships / Education Assistance to current TGRA members wishing to participate in IGRA sanctioned Certification programs in the amount of maximum of \$500 each for a total of \$2,000. All distributions will be made as a reimbursement with proof of expenditures (ie, receipts).
- 3 This will be a one-time distribution of funds to the selected person to receive funds per program guidelines.

Eligibility / Requirements

- 1 For IGRA sanctioned Certification programs: applicant must be a TGRA member in good standing for a period of at least 6 months immediately prior to application date.
- 2 Eligible to apply for funds:
 - a. TGRA member
 - b. Direct relative of a TGRA member: i.e. spouse / partner, child, grandchild
 - c. External candidates that volunteer at TGRA sponsored rodeo (i.e.: rodeo director mentoring)

Terms and Conditions:

- 1 The scholarship will be limited to tuition and books exclusively and will be nonrefundable.
- 2 Payment of scholarship funds will be paid upon proof of enrollment.

Submission:

- 1 Application package includes:
 - a. application
 - b. essay on “Why I’m deserving of the TGRA / Johnathan Juricek Scholarship.”

Applicant submissions will be reviewed by a 3 person team of current TGRA members, with the selected recipients to be notified by the committee.

Distribution of funds:

- 1 Will be made directly to the applicants school or program Provider unless the distribution is a reimbursement for IGRA certification program where receipts are required to be supplied.

****** Note: any distribution not made directly to the school for \$500 or more will be considered income and have to be 1099 reported.**
